Big Legislative Issues:

- Concern that the legislature will not address McCleary.
- Much of the legislative conversations are on hold until after the election, especially those addressing sanctions, COLAs, etc.
- Randy Dorn will be focusing on assessment for this session, and will reintroduce his bill.

AESD LEGISLATIVE ADVOCACY PRIORITIES BROCHURE

John Welch, Puget Sound ESD Superintendent, shared that the AESD Legislative brochure was in the process of being delivered to the 9 ESDs. A PDF version will also be distributed for easy use in working with customers.

LEGISLATIVE ADVOCACY WORKSHOP

Advocacy will be essential in this next legislative session. Jim Fromhold and Marcia Fromhold worked with the AESD Board on what would be the best points to cover with a legislator should an opportunity arise.
