# **AESD EXECUTIVE BOARD MEETING MINUTES**

September 26, 2022 // In-person: PSESD and Zoom // 12:00pm-2:00pm https://esd113.zoom.us/j/86777333948

Welcome/Introduction - Lead: President Elect, Terry Brandon Welcome, Introductions, Pledge of Allegiance, Review of agenda

The meeting was called to order at 12:19pm. Terry led the board in the pledge of allegiance. The attendees went around the room and introduced themselves.

**Consent Agenda** - Lead: President Elect, Terry Brandon Terry asked if the board had reviewed the agenda and minutes from the 6/28/22 AESD Executive Board meeting, and if they had any changes. No changes were requested.

III. AESD Network Initiative Deeper Dive: Region 16 Comprehensive Center Lead: Tim Merlino, Jessica Vavrus Guests: Bernie Sorenson, R16CC Director; Beth Geiger, R16CC WA State Director

Bernie Sorenson and Beth Geiger presented an overview of the work of the Region 16 Comprehensive Center. Bernie invited the board to discuss with each other what they know about Regional Comprehensive Centers, what work the Region 16 Comprehensive Center had accomplished that they knew of, and why this work might be funded by the U.S. Dept. of Education. The Board and Superintendents discussed with each other. Bernie then gave an overview of the Regional Comprehensive Center network and the Region 16 Comprehensive Center role, mission, vision, and history. Region 16 works within multiple circles of stewardship including the Tribal Advisory Board, Advisory Board, and Community of Stewards. R16CC has overarching goals and then each state, WA, OR, and AK, has an individual State Service Plan that supports the center work.

Upcoming professional development events include: The Fall Professional Book Study, the Winter Professional Book Studies, Equitable Collaboration of Students, Families, and Communities, quarterly convenings of Leaders in Native Education, and a Learning at Lunch series.

Beth Geiger shared the progress and history of the Washington State Service Plan, emphasizing the relationship-building that was crucial to the work. The WA arm of R16CC works closely with the WA Tribal Advisory Board and OSPI. Key Region 16 WA projects include the Share Our Voices, Hear Our Stories listening sessions, the Circles of Reflection pilot, database research project, consultation handbook, Tribal sovereignty and consultation training, Native student supports research, Indigenous school improvement research, tools and training for indigenous educators and educators of indigenous students, and supports for indigenous educator recruitment. Much of the Year 4 goals are focused on connecting people, agencies, and resources.

Beth and Bernie took questions from the board. Kevin Chase and Terry Brandon reflected on the positive changes the relationship-building efforts have created. Jessica shared that the proposal for the next grant cycle is underway.

### IV. Legislative Updates - Lead: Melissa Gombosky (virtual) / Terry Brandon

### **AESD Legislative Update**

Melissa reminded the Executive Board that we are in the middle of election season, which is a hard time to get lawmakers focused on policy. The revenue and forecast council and predicting a stable budget for the state. Melissa shared a few top-of-mind policies for legislators, including special education, transportation, and budgets. There is also interest in the capital budget. The OSPI 2023-25 Decision Package includes dual language expansion, work experience contributing to graduation, universal free school meals, dual credit support, credit flexibility, (add the rest)

## **AESD Legislative Priorities**

- Safety & Student Well-Being, \$2.1 M per year
- Sustain and expand student mental and behavioral health services for schools and students, \$7.8
  M per year
- Early Learning

### Group Discussion with guiding questions:

- How do ESD Boards' Legislative Representative connect with AESD priorities?
- What is the role of ESD Board Legislative Representatives?
- Are these individuals the same as Executive Board Reps?

The board discussed how different ESDs approach this role. Dale McDaniel shared how the ESD 113 rep keeps the board informed, John Welch shared that ESD 121 has two reps that are voted in each year that advocate in the legislature and at events. ESD 112 is the same as ESD 121. ESD 101 does not have a legislative rep but is willing to work with the Superintendent if needed to lend voice to regional priorities. ESD 105 has one elected legislative rep with a minimal role and has hired Melissa Gombosky to lobby directly for ESD 105. Terry Brandon is the legislative rep for ESD 123 and does not have much guidance for the role.

V. Network Redesign Work: Updates/Interlocal Revision Proposals/Process/Strategic Plan Follow-up Lead: Tim Merlino, Michelle Price, John Welch

### **Interlocal Revision Proposals**

Michelle Price gave an overview of the interlocal redesign process. The overall goals of this process include:

- Detangle AESD Association from AESD Network
- Revise AESD Interlocal Agreement to create one document that defines and contains all agreements/tenets of the AESD/ESD Network

• Clarify and centralize AESD governing structures, roles, processes, decision making between AESD Executive Board and Leadership Council

## Work Group Updates

- Workgroup (ESD Supts) met and reviewed the interlocal territorial agreement and decided it is ready to go. The agreement will be sent to all ESD boards for consistency.
- A big shift is the creation of an administrative ESD that provides infrastructure, fiscal, and staff support, and would manage the AESD Network budget.
- There is a historical precedent for dues and running a small budget for Network needs, different from the carryover from the Annual Conference. It is legislatively authorized to have a WSSDA-like organization to support the AESD boards.
- The group suggested a staggered first and second reading approach. The first reading will occur in November. It was suggested to have a board study meeting after the 1<sup>st</sup> reading so local boards are informed prior to the annual budget adoption.
- This process provides opportunities for setting best practices, and for closer alignment of member boards.

### Strategic Plan

The board discussed the strategic plan with the following questions:

How do these goals relate to the AESD Network and how might these be different for the Association? The goals are more representative of the Network than Association, should the board consider the goals should be the same, or keep different and have the Association only focus on Board Member development? What are the advantages to detangling the Network strategic plan from the Association strategic plan?

### Actions:

Terry Brandon will draft goals for people to respond to.
