# 2024 Legislative Platform



### SCHOOL-BASED MENTAL & BEHAVIORAL HEALTH

Washington's students continue to struggle with heightened stress levels, anxiety, and social isolation. Too many students are uninsured or underinsured and face barriers to seeking medical help. With licenses to provide mental health therapy, ESDs are uniquely equipped to bridge the gap between education and behavioral health. School-based behavioral health services can increase student access by co-locating services and embedding behavioral health staff in school buildings.

#### **Proposed Solutions**

- MAINTAIN last year's one-time expenditure to ensure continued school-based services to more than 2,000 students in 96 schools within 68 districts.
- EXPAND school-based services to approximately 50
  additional school districts, prioritizing services to sites
  farthest from existing behavioral and mental health services.
- **REMOVE barriers** for ESDs and school districts accessing Medicaid for school-based services. The current system is not structured for school settings or for providing youth and adolescent care. And under the current state Medicaid Plan, adolescent therapists aren't funded for full care.

### INTEGRATED INCLUSIONARY PRACTICES & MULTI-TIERED SYSTEMS OF SUPPORT

ESD teams help school and district leadership teams support **all** students — especially those with disabilities. In 2022, 140 schools engaged with an IPP coordinator. These schools experienced a 14.08 percentage point *increase* in the number of students with disabilities spending 80% to 100% of their day in the general education setting.

#### **Proposed Solutions**

- **RESTORE full funding**. Funding is currently scheduled to end after the 2023-24 school year.
- **EXPAND regional coaching and technical assistance** for district leaders who need support creating inclusionary systems.

#### **SCHOOL DISTRICT SUPPORT:**

The AESD Network urges the Legislature to fully resource school districts to serve *every* student. This includes greater investments in special education; student transportation systems; and appropriate, realistic staffing levels and operational support.
